4. The proposed school shall not use the premises including staff, play ground or any moveable or immovable property of any other school registered under the respective Act of state Government

5. The state Government will not bear any financial or administrative responsibility of the proposed school. The state Government will not be responsible. If the School /Institution breached of any rules/norms or regulations laid down by above said board.

5. The institution shall have to obtain necessary permission of Government of India and other concerned authorities where it is necessary.

7. The School/Institute shall be open to inspection by the DEO/DPEO, GSHSEB, COS or the officers of the District Education Office, duly authorized in this behalf as per relevant by-laws of the concerned Board.

8. No grants or any financial assistance shall be given by the State Government to the School / Institute.

9. The School/Institution shall produce an undertaking to the effect that it shall follow the provisions of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017 and the rules made there under.

10. The School shall upload their data to U-DISE System (Unified District Information System for Education) and update it regularly.

11. In case of any breach or contravention of any of the provisions of the Affiliation, bye laws of the respective Board or any provisions of the Gujarat Self-Financed Schools (Regulation of Fees) Act-2017, and the rules made there under or any of the conditions of the NOC, State Government reserves its right to withdraw the NOC.

12. This NOC is valid for six months from the date of issuance & this NOC is for the purpose of getting affiliation

with Central Board of Secondary Education, New Delhi Only.
