**Subject: Grant of Recognition to a Private Non-Granted Primary School**

With reference to your application and correspondence regarding recognition of **Global Discovery Academy, Sevasi, Taluka Vadodara, District Vadodara (English Medium)**, approval is hereby granted from **June 2013** to run **Standards 6 to 8 (Non-Granted Upper Primary Section)**, subject to the following conditions:

1. At the time of admission, the school management shall not collect any capitation fee, donation, or security deposit from parents or students.
2. No child shall be denied admission due to lack of proof of age or other documents. Admission shall not be refused on the grounds of religion, caste, community, or any other discriminatory reason.
3. The school shall ensure the following:
  - No child admitted to the school shall be detained in any class or expelled until completion of elementary education.
  - No child shall be subjected to physical punishment or mental harassment.
  - No child shall be required to pass any board examination until completion of elementary education.
  - On completion of elementary education, a certificate shall be issued to every student.
  - Teachers shall be appointed as per the provisions of the Bombay Primary Education Act, 1947 and Bombay Primary Education Rules, 1949, with prescribed qualifications.
  - No teacher shall engage in private tuition activities.
4. Only textbooks approved by the competent authority appointed by the State Government shall be taught in the school.
5. Admissions shall be granted only according to the infrastructure and student capacity available in the school.




6. The school shall not run any unauthorized classes within the premises nor operate under another name to conduct unapproved classes.
7. The school building, playground, and other facilities shall be used solely for educational purposes and educational development. Only a society registered under the Societies Registration Act, 1860 or any legally authorized body shall run the school.
8. The school shall not be run by any individual or group for profit-making purposes.
9. The financial accounts of the school must be audited by a Chartered Accountant. Certified audit reports and required statements must be submitted, and copies must be produced before the office when demanded.
10. All applicable provisions of Government resolutions and instructions shall be complied with. Further, any deficiencies pointed out by the competent authority must be rectified within the stipulated time.
11. As per Government Resolution of the Education Department dated **18/02/2011**, Resolution No.: PRE/112011-149-K, according to which, during each academic year the Upper Primary Section (Standards 1 to 5) shall function for: A minimum of **200 working days**, and A minimum of **800 instructional hours** per year.
12. If the above conditions are not complied with, the recognition granted to the school shall be withdrawn.
13. All safety and other prescribed norms must be followed, and deficiencies, if any, must be rectified immediately.
14. Subject to compliance with the above conditions, permission is granted to **Global Discovery Academy, Sevasi, Taluka Vadodara, District Vadodara (English Medium)** to run Standards 6 to 8 (Non-Granted) from June 2013.
